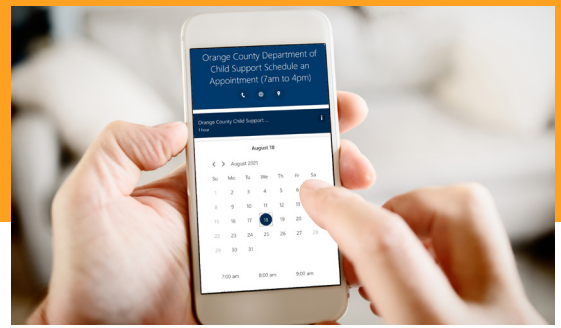

Attending Court from Home

What You Need to Know



To adapt to changes over the past year, the Orange County Superior Court, in partnership with OC CSS, has conducted all court hearings remotely.

If you have an upcoming remote court hearing, we are here to help you through the process and ensure you have the information and support to attend using your smart phone, tablet or computer.

What you need to know about attending court from home:



Your remote hearing will be held using Zoom. Download Zoom instructions [here](#).



You will receive an email with a link to attend your hearing using Zoom. If we do not have an email address for you, you will receive this information in the mail.

Introducing the Child Support Debt Reduction Program

Do you owe past due child support? If your past due child support payments include a time your child(ren) received cash assistance, you may be able to qualify for the new Child Support Debt Reduction Program.

How Can This Program Help Me?

If you qualify, the Child Support Debt Reduction Program reduces the amount of past due child support you owe and sets up a payment plan on some or all of the remaining balance.

Benefits include:



Work with us to agree on a payment amount that fits your budget.



A monthly payment plan option that can make payments on your past due balance easier to manage.



Past due child support has interest added every month. Less interest is added when you reduce your past due balance.

Upcoming Changes to

Customer CONNECT

To enhance customer security, changes are coming to the self-service portal, Customer Connect. Beginning August 15, 2021, you will need your Participant Identification (PAR ID) number to log in and access your account.

Find your PAR ID number:

- On mailed paper statements
- On *most* child support letters
- By logging into your Customer Connect account before August 15

As of February 2021, debit and credit card payments are charged a 1.9% fee when paying online, by phone or at our cashier windows and 2.2% fee when paying at our in-office TouchPay Kiosk.

Way2Go Electronic Payment Card



The Electronic Payment Card program switched to the Way2Go card in July 2020. If you receive payments through an electronic payment card, you should have received and activated a new card. The Way2Go card offers new features including an embedded microchip for added security and the ability to get up to five companion cards.

Do you need to change the amount you pay or are you experiencing a change in circumstance? If you are experiencing changes, such as custody, parenting time or an increase or decrease in income, it may be time to request a review of your child support order. By reviewing your order, we can help make sure it matches your current circumstance.

Upon your request, a case manager will review your case to determine if you qualify for a change in your child support amount. Qualifying changes in circumstances may include:

- ✓ Increase or decrease in income
- ✓ Child care expenses
- ✓ Custody
- ✓ Health insurance coverage
- ✓ Employment status
- ✓ Benefits
- ✓ Parenting time

We work with both parents to find the best possible solution that works for everyone involved. During the review process, you will be asked to provide the following information:

- ✓ Three most recent pay stubs and copies of your recent federal tax returns
- ✓ Proof of child support payments for other biological children
- ✓ Custody/visitation schedule (including dates and length of time)
- ✓ Schedule C and Profit/Loss Statement (if self-employed)

Is there a way to change my order from home?

Yes, there is! We can schedule a video appointment for both parents to reach an agreement. If both parents agree, a legal document can be signed and filed, resulting in a final order.

An Income and Expense Declaration (I&E) is needed to complete the process and can be eFiled online from home. Learn more about eFiling [here](#).

Stipulation of Orders (Agreement)

Easy, Fast, and Simple!

OC CSS helps parents obtain a child support order by reaching an agreement.

What is a Stipulation?

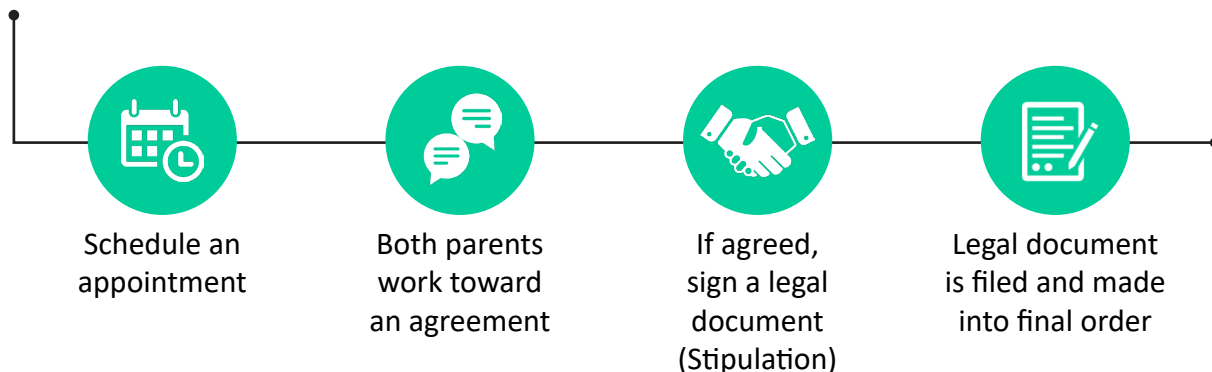
A stipulation is a legal child support order where both parents reach an agreement on financial, medical support and/or parentage for their child(ren). The stipulation is signed by both parents.

Benefits of Stipulation Include:

- ✓ No cost
- ✓ Parents work together to reach an agreement
- ✓ We do the paperwork
- ✓ Flexible video appointments available
- ✓ Private environment for in-person appointments
- ✓ Free parking at our office

... About Parentage



Establishing parentage is the process of determining the legal parents of a child born to unmarried parents or through assisted reproduction. Establishing legal parentage through the voluntary Parentage Opportunity Program (POP) provides legal and financial rights to parents and children, including:

The right to seek custody or visitation

Placing both parents' names on the child's birth certificate

Entitling the child to health coverage under either parent's plan

Social Security and other benefits from either parent

OC CSS offers different options to legally establish parentage, including:



Genetic Testing: Free genetic testing with a simple cheek swab.



Parentage Opportunity Program (POP): Eligible parents voluntarily complete and sign a Voluntary Declaration of Parentage (VDOP) form which has the same effect as a court judgment.



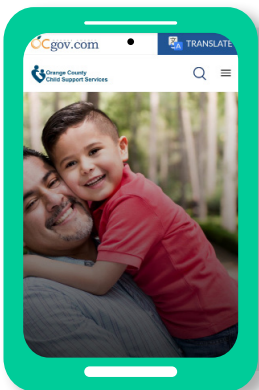
Legal Process: Parentage can be established by the Court.

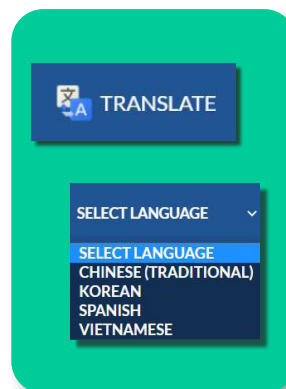
Have You Seen Our New Website?

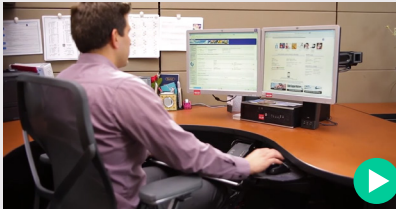

TouchPay Kiosk

Make payments in person at the easy-to-use kiosk with your secure TouchPay card.



Cashier Window

Make payments in person at the window using cash, checks, money orders, credit and debit cards.

When using a credit or debit card, a 1.9% fee will be charged when paying online, by phone or at the cashier window, and a 2.2% fee will be charged at the TouchPay Kiosk.

Using PayPal

Make cash payments at participating MoneyGram locations with your participant identification number and access code 14630. Visit moneygram.com for a list of participating locations.

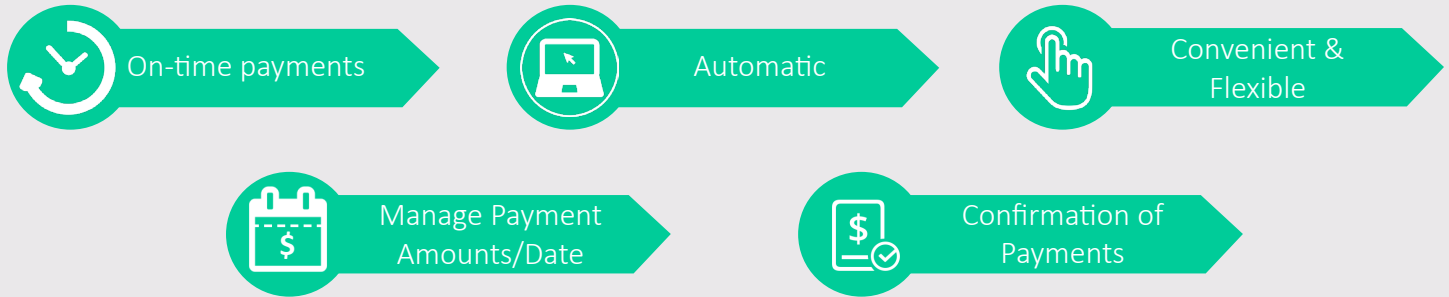
A \$1.99 fee applies when using PayNearMe or MoneyGram. A 2.49% fee will be charged when using PayPal.

Sign Up for Auto Payments Today

Setup is Easy, Convenient, and Secure

Did you know you can easily set up recurring payments to pay your child support using a credit card, debit card or bank account? You can auto pay a set amount every month to make sure a payment is made toward your child support obligation. The amount paid can be adjusted as necessary.

Benefits include:





Ensure your payment is received by the 20th of each month for credit in the month the payment is intended for.

Receiving Payments

We offer convenient ways to receive your child support payments.

-  **Child Support Debit MasterCard®**
The Electronic Payment Card (EPC) program allows your child support payments to be automatically deposited to a MasterCard® debit card. With the EPC program, you have online account access, toll-free customer service and 24/7 access to payments.
-  **Direct Deposit**
Direct Deposit allows you to securely receive child support payments directly into a checking or savings account.

Both options provide fast and safe access to your child support payments.
